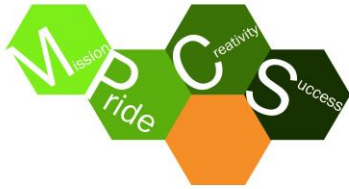

Millville Public Charter School will be offering a Before and After Care Program for the 2017-18 school year. The program will begin the first week of school and will include early dismissal days. A registration form must be completed along with a \$25.00 nonrefundable registration fee. The form and fee can be mailed to the above address or returned with your child the first day they attend the program. If cash is sent in with your child, please put it in an envelope with your child's name and homeroom and "Before and Aftercare program" clearly labeled. Checks should be made payable to Millville Public Charter School.

This year you will be required to buy passes for your child's time in the program. Hourly passes will be sold in increments of 5 hours for \$15.00, 10 hours for \$30.00, and 15 hours for \$45.00. You must purchase a pass in advance of your child attending the program. Passes will be available the first day of the program for your purchase and every day during the program. If your child does not have a pass, they will not be allowed in the program and you will be called to immediately pick them up. The pass will be kept at school with the program staff and will be punched and dated when services are rendered. The before care fee is \$3.00. If your child is in the program without a pass and one is not purchased upon their pick up and this occurs three times this will be cause for dismissal from the program.

Times for the program

Before care: begins at 7:00 a.m. and ends when school begins
Aftercare: 4:00 p.m. to 6:00 p.m.

Before and After Care will not be provided if school is delayed or closed due to inclement weather. You are required to sign your child into before care and out of aftercare.

MPCS will assess \$5.00 late fee for every fifteen minutes the student is left after 6 p.m. However, if your child is not picked up by 6:15 p.m., it may be necessary to call the police and/or the Division of Youth and Family Services for assistance. Repeated late pickups will be cause for dismissal from the program.
